### **Report on the Formal Public Consultation**

The independent report on the recent public consultation will be received by the WVMP Development Project Board at its next meeting on Monday the 14<sup>th</sup> of June.

Shortly after this on the 30<sup>th</sup> June it will be presented to the Trust Board and from then on available on the PCT website.

The report will also be shared with the Consultation Reference Group and the Practice. The Consultation Reference Group has been meeting through out the project and is made up of representatives from some of the local action groups, the parish councils, the Local Involvement Network and patients of the practice.

All the registered households of the Wrington Vale Medical Practice will be sent a leaflet that outlines the findings from the consultation and the full report can be requested or downloaded from the PCT website.

The Report will illustrate the background and context of the consultation, the methodology used and the participation in the consultation process.

It will identify the views on the current facilities, additional services, the options and the evaluation criteria, as well as views on the consultation process itself.



This phase of the project will then come to an end but that doesn't mean that your involvement comes to an end.

We have mentioned the Business Case Review Group before in this Newsletter and they are working on the detail for all of the options.

A Community Network event will be held in June/July that will consider the detail and identify a short list of options for further consideration.

We will keep you informed through the Newsletters and through the PCT Website.

Following on from last month's invitation to register for the community network we now have over 20 names and contact details.

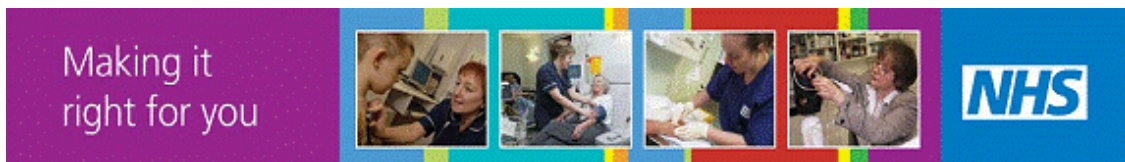
We can accommodate more, so if you wish to remain involved in this development and can spare the time to attend a community event please register your interest.
